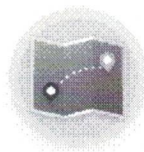

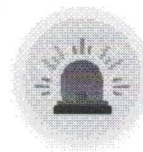

KNOW ALL MEN BY THESE PRESENTS, that LendCare Capital Inc. (the "Bank/Lender"), hereby appoints First Canadian Title Company Limited ("FCT"), presently all operating at 2235 Sheridan Garden Drive, Oakville, ON and each person who is employed at any given time by FCT and holds a present position with FCT, to be its power of attorney for the specific purposes set out herein. The (Bank's or Lender's) power of attorney is authorized to do on its behalf all acts necessary for the performance by FCT of the services, which the (Bank/Lender) asks of them to perform in respect of the repossession and/or sale of motor vehicles and other secured assets. 


